The five decisions that matter most

1. Determine data ownership.

3. Define data correctness.

Create standards for what constitutes correct data to avoid inconsistencies.

4. Centralize data storage.

Use a centralized system to reduce duplicates and improve data access.

5. Leverage analytics.

Utilize analytics to track trends and improve negotiation outcomes.

Phase 3	Days 46–70

Phase 4	Days 71–90
<ul style="list-style-type: none">• Finalize system setup• Launch system organization-wide• Monitor performance
